Clerk's Report to 28th February, 2019

Severn Trent Water Main – The section of Selsley Road between Blacklow Close and the entrance to Boundary Court is due to be closed from the 11th March to the 5th April. A dropin session for residents was held in the Village Hall on the 28th February to inform residents and answer questions.

Drain Clearance on Bospin Lane – Gloucestershire County Council (GCC) have now jetted the drain at the bottom of Bospin Lane. Together with the work carried out by the landowner at the top of the lane to divert water away from the road, this should improve drainage issues.

Defibrillator Course – Several residents have made a request for a second course in the use of the defibrillator. Nick Morrall, Learning Co-ordinator – Skills and Accredited Learning in First Aid at GCC has offered to run two courses free of charge for which a limited number of spaces will be available. They will cover CPR, dealing with an unconscious casualty and use of a defibrillator. A date for those sessions is currently being arranged.

Cycle Path – Maintenance work - Gloucestershire County Council have plans to resurface sections of the path from Dudbridge to Nailsworth which are not already surfaced. They are awaiting confirmation that Gloucestershire Wildlife Trust has secured European funding. They are also creating extra space for users to pass at Inchbrook and carrying out some maintenance work in preparation for consultation on the creation of a right of way along the route. All relevant parties, including user groups and parishes etc. will be consulted in due course.

Development at Southbank – Stroud District Council are in the process of finalising technical design matters with the contractor Speller Metcalfe, part of which involved further ground investigations and finalising an engineering solution for the site. Speller Metcalfe are currently in the process of reviewing their programme; they had hoped to start in January. A programme is expected shortly and the revised start time is likely to be in early March. Project Manager, Kimberley Read has been invited to attend a meeting in order to update residents and answer any questions they might have.

Grant applications – An entry has been made in the Woodchester Word inviting local organisations looking for funding to complete an application form by the end of May. The project must benefit the residents of Woodchester. Applications will then be considered at the Parish Council meeting on 6th June.
