What is a Parish Council?

A **Parish Council** is a civil local authority and is the lowest tier of local government. They are elected corporate bodies, have tax raising powers, and are responsible for areas known as civil parishes.

Parish Councils have the power to tax their residents to support their operations and to carry out local projects, and this is done through the council tax system by levying a precept on the council tax paid by the residents of the parish. Although there is no limit to the amount that can be raised, the money can only be raised for a limited number of purposes as defined in the 1894 Act.

A parish council consists of the chairman and not fewer than five elected unpaid **Parish Councillors** who are elected to serve for four years. A quorum of the main council is at least one-third of the members, or three members, whichever is the greater. The administration of the Council is managed by its **Parish Clerk**, a paid employee appointed by the council. Councillors are expected to adhere to the "Nolan principles" of conduct in public life.

A parish council must hold an **Annual Meeting** and at least three other **Council Meetings** in a year – Woodchester Parish Council holds meetings on the first Thursday of every other month, normally in the Village Hall. Every meeting is open to the public, who are encouraged to attend. Public notice of meetings of the council and its committees must be given at least three clear days before and these are displayed on the village notice boards and the parish council website. Procedures for the conduct of meetings are set out in Schedule 12 of the Local Government Act 1972.

The **activities of Parish Councils** fall into three main categories: representing the local community, delivering services to meet local needs, and improving quality of life and community well-being.

Parish Councils are responsible for the provision, maintenance and protection of roadside verges, bus shelters, grit bins, dog bins, litter bins, maintenance of rights of way, guardianship of common land (such as village greens), maintenance of war memorials, public seats, etc. Parish councils have the statutory right to be consulted by the district, county council or unitary authority on all planning applications in their area.
