# Clerk's Report to 25th February, 2021

# Gloucestershire Highways (GH)

- Cycle Track The section between Pauls Rise and Birds Crossing remains closed for essential bridge repairs. The repairs are planned for late March or Early April and will take about a week. Maps to show the diversion routes and some diversion signage is planned (notably for the bottom of The Garden). Plus 'pedestrian in the road' signs for Southfield Road.
- Tree work at the MTB trails has been completed. The next inspection is planned for mid-summer.
- Blocked Drains Drains on A46 at Rooksmoor have been cleansed again and those on Bear Hill should be done this week. We are waiting to hear back about sweeping Rooksmoor Hill.

#### Woodchester Park

Tree Work - Felling work has been delayed and will now continue to the end of April in phases. Some footpaths will need to be closed including at weekends. From the middle to the end of March the Inchbrook entrance to the park will be closed Monday to Friday. Work is also planned in those weeks between the main car park and the Mansion, however the entrance will remain open with banksmen at either end of the works to tell visitors when it is safe to proceed (hence visitors should expect delays). Signs will be erected to inform visitors of any closures.

#### Village Charities

 Seys & Bridges Educational Foundation has merged with St Loe's School Exhibition Fund. Diana Fowler (who was appointed in 1974) is not continuing as trustee of the new charity; St Loe's, Seys & Bridges Foundation. The other trustee the PC appointed is Liz Ewart-James (appointed in 1992).

# End of legislation allowing remote meetings

 Legislation to allow local authorities to hold remote meetings is due to end on 7th May, meaning that after that time the PC will need to meet face to face. A number of National bodies (e.g. NALC and SLCC) are pressing the Government to extend the legislation.
