Clerks Report to 6th May 2021

Highways and Rights of way

- 'Cycle track'; The bridge at Birds Crossing is now open and work is planned w/c 10th May to complete the resurfacing of the 'cycle trail' behind the Rooksmoor Development and near the A46 layby in South Woodchester. The track will be closed for those repairs.
- Frogmarsh road surface; We are still awaiting further information about the new road surface needed in Frogmarsh at the Bottle Green Junction but all parties are agreed the situation needs rectifying. Email at end of April said Gloucestershire Highways were seeking further advice about a suitable material to use.
- **Bus Stop on A46;** There is a new trial bus stop on the A46 to replace the one removed during the Rooksmoor Development.
- **Footpath Open:** The footpath through the Rooksmoor development connecting the A46 to the 'cycle track' is now open. It is a flight of stairs with a track to push a bicycle up.
- Other reported issues: At end of April, GCC stated they plan to rectify the drainage problem on the A46 adjacent to Manor Drive, although the scheme is still in development and with no date as yet for the work. PC have received a complaint about rights of way as described in a walk posted on our website. The post has been removed while amendments are made. Various other issues reported (trees down, blocked drains etc.)

Election

• Woodchester Parish had an uncontested election on 6th May and we welcome two new Parish Councillors: Elizabeth Hasinski and Caroline Noon.

Clerk Training

To date the Clerk has undertaken four two-hour training sessions run by GAPTC, two general
introductory training sessions, one on finance and one on conducting the Audit. In addition,
the Clerk undertook training from HMRC on completing end of year submissions and starting
the new tax year.

Notes on Town and Parish Information Virtual Meeting 21/4/21 (minutes to follow if requested)

This meeting had a focus on waste and recycling and the police, but also covered other matters.

Waste and recycling (Mike Towson): 13, 500 garden waste subscribers. Overall, 20% more household waste due to home working primarily. Inc in fly tipping from 63 reported cases in June 2019 to 174 in June 2020. There has been more general littering, more use of dog bins and more requests for street sweeping. SDC are introducing a trial of beige litter bags for litter picked waste, so refuse collectors know what is litter picked. I am currently trying to find out more about this. SDC are now lending out litter picking materials again. They plan to publish a supplementary waste policy on their website and have a renewed emphasis on education going forward. Also, better in cab technology for communications. They can offer parishes replacement bins for their residents if the Parish has the storage. SDC have a moratorium on additional dog bins (there are 550 in the area). There was discussion about the need for an additional recycling centre for the area. They said they could consider providing recycling bins on play areas if applications were made.

Police (Insp Paul Cruise). Low levels of crime generally in this area and a reduction in lockdown. Overall, 60 reported crimes per 100,000 population. Police are focusing on a multi-agency approach to antisocial behaviour where possible. There has been a reduced number of officers since last August, but there are new recruits starting over coming months.

Highways (Paul Helbrow): extra crews filling potholes, monthly inspections of the main roads, but please report potholes as some roads are only checked annually. Capital resurfacing scheme was mostly achieved, reduced budget for 2021/22. Applications for Traffic Regulation Orders (TRO's) are currently suspended until they have finished developing policy on this and have fuller guidance. New policy may steer towards other traffic calming measures. 20mph applications need to be on safety grounds with evidence e.g. speed data and with funding support. County Councillors budget has now been agreed and a program of works is likely to be agreed by end of May. Broach possible schemes for this money with County Councillor after 6th May elections. Parking Orders e.g. double yellow lines at junctions, are more economic if several locations are included in one order. Mostly funding needs to come from Parish or from County Councillor's budget. Obstructive parking: If cars are parked in a way that clearly obstructs the highway residents can report it (with photographic evidence) and police will send letter.

Other matters: Community hubs (Mike Hammond) are being developed to support local communities. https://www.stroud.gov.uk/housing/council-tenants-and-leaseholders/our-customers-matter/get-involved/community-hubs Neighborhood wardens (Bev Owen) busy dealing with COVID signage, supporting vulnerable people and dealing with antisocial behaviour. They have also helped with the distribution of food parcels and will have election duties. They are working on a new information page coming soon on SDC website dealing with fly tipping and enforcement. Environmental Protection (Dave Jackson) (4 people on Environmental Protection, 2 on animal welfare). 86% more bonfire complaints in last 12 months than in the previous 12. Increase in reports of noise nuisance with COVID. Gloucestershire fire and rescue (Tim Clapp), firefighters have been driving ambulances and involved in track and trace and delivery of PPE. Safe and Well (home safety checks) is now up and running again.
