### Clerk's Report to 27th August, 2020

#### Gloucestershire Highways (GH)

- A46 closure Contacted GH to arrange an improvement in the diversion arrangements. Cllr. Baynham-Honri followed this up with a representative from GH
- Water Lane Work has begun on Water Lane, but is not complete. This has left a trench which is full of water. The safety barriers placed by GH have been removed, resulting in a potentially hazardous site. GH have been contacted to ask for a completion date and that, in the meantime, the site be made safe
- Fallen Tree on Selsley Road This was cleared by residents to enable cars to pass.
  GH have been contacted to ask that remaining branches on the sides of the road be removed to prevent any subsequent issues
- Verge on Selsley Road above the Village Shop Clerk has requested this be cut back as the brambles are now encroaching, forcing traffic into the road
- Frogmarsh Bridge closure Requests were made for improved access to the bus stop and signage for HGV drivers to and from Frogmarsh Mill. Cllr. Baynham-Honri followed this up with a representative from GH.
- Road Closure The A46 is due to be closed from the 5<sup>th</sup>-7<sup>th</sup> October between the hours of 9.30am-3.30pm for tree work. The closed section will extend from just north of St. Mary's Hill to just south of Frogmarsh Lane.
- **Hedge on Selsley Road below Southfield Road** This will be cut back on Monday 7<sup>th</sup> September. Notices will be placed on car windscreens to ask that the road is kept clear on that day.
- Football Pitch A grant was received from the FA Foundation which will enable the grass to be cut and possibly the club house to be tidied up. It's hoped the Club will be reformed for the 2021 season.
