## Clerks Report to 3rd May 2022

Highways and Rights of Way: Selsley Road resurfacing has now been completed and additional 'slow' signs are to be added at the Parish Council's request. The slow sign has also been repainted at Frogmarsh at the request of the Parish Council. There has been a problem installing power in the Rooksmoor development leading to ongoing issues with traffic lights on the A46. Concerns have been expressed both to the Parish and County Councillor about the possible closure of the new permissive pathway in the Rooksmoor Development and the proposed rerouting of the public footpath. Concerns include accessibility and safety of pedestrians exiting further along the A46 and having to walk back to Scotts Crossing. Councillors attended a meeting on site and an alternative route was proposed which allows for an exit closer to the crossing. The Parish council are awaiting confirmation about this.

**Maintenance:** In addition to his contracted jobs our maintenance contractor has recently cleared the vegetation along South Woodchester High Street and used a long net to remove litter from the stream. He plans to replace the Perspex in the Paul's Rise notice board and to replace the backing in Frogmarsh notice board over coming weeks.

**New Village Benches:** The new bench in the triangle at Frogmarsh, kindly provided by the Stroud Valleys Project, has now been installed. This is part of the wider development of that area as a place for wildlife and relaxation.

**Finance:** Woodchester Parish Council has received a further £139.24 in CIL funding. This needs to be spent by April 2027. In total we now have £871.24 in CIL funding. CIL money must be spent on the provision or maintenance/improvement of infrastructure needed to support development. We have also received the first half of the precept for this year.

**Clerk Salary:** The National Joint Council for Local Government Services agreed new rates of pay applicable from 1st April 2021, with staff awarded back pay to that date. The Clerk salary also increased by one increment to SCP 14 from 1<sup>st</sup> April 2022.

Training: Cllr Noon has attended GAPTC Councillor training.

**Grants:** grants of up to £500 are available from the Parish Council. Grants are for local charities, voluntary groups or community organisations with projects of direct benefit to Parishioners. Applications need to be received by 31st May for consideration this year. Full details and application form on the website or from the Clerk. Clerk has advertised these on the website, Facebook and through the notice boards.

**Litter pick:** Several residents borrow litter picking equipment on an ongoing basis from the Parish Council and work hard to reduce the amount of litter in the village. A number of volunteers came along to the annual litter pick and helped remove 10/12 sacks of litter as well as an old motorbike from the banks of the stream, a broken chair, a road sign and old guttering.

**Bike trails:** The annual safety check has been completed with only minor comment. The fence for the MTB trail is due to be moved back one meter this week as part of the Parish Council agreement when taking on the lease for the new play area.

**Play area:** The lease for the new northern site has been agreed in principle and is currently going through GCC legal department. The soil sampling for this site has been completed and indicated no problems. It has been agreed to fell

all the trees on the site, but due to the power lines, this needs to be completed by a tree surgeon with the required licensing. This process is ongoing. Funding; the total required for this project is £72,000, Cllr Dunbar has submitted appropriate grant applications and is waiting to hear. The current reserve for the play area stands at £9,419.33 with £1000 due soon from 'build back better and £600 due from the Langtree Trust. A further £2000 has been promised from a local firm.

Welcome Packs: A total of 15 welcome packs have been distributed since the last meeting.
